Our production vehicles and various pieces of film equipment will be located on:

- East Side of Munro Street between Queen Street East and laneway
- West Side of Hamilton Street between Queen Street East and Thompson Street
- South Side of Thompson Street between Broadview Avenue and Munro Street

We will begin reserving the above areas with cones on October 12th at 7am, with vehicles arriving October 13th at around 5am, and departing after our filming is completed on the same day October 13th at around 6pm.

Please note that we are planning on an early start time on Tuesday October 13, 2020. We will be sending a member of our production staff out to the area with the signature release forms and will be distributed to residents in the area. Displaced permit parkers affected by our filming activities are kindly asked to park in their driveways (if applicable), surrounding streets, nearby pay lots.
