**We will be filming Exterior scenes adjacent to
Chez Nous Wine Bar located at 798 Queen Street East
February 11th between the hours of 7am and 1pm**

PREP: Feb 9, 10 between 7am and 7pm

FILM: Feb 11 between 7am and 1 pm

WRAP: Feb 12, 13 between 7am and 7pm

Our production vehicles and various pieces of film equipment will be located on:

- Queen Street East, North and South Sides, between Grant Street and Boulton Avenue
- Queen Street East, North side, between Grant Street and Logan Avenue ** rush hour exemption requested for filming day **
- Boulton Avenue, West Side, from Queen Street East to #22 Boulton Avenue (prep/shoot/wrap days)
- DeGrassi Street, East side, approximately 100m north of Queen Street East
- Basecamp to be located at 1141 Eastern Avenue

We will begin reserving the spaces on Degrassi Street and Boulton Streets on February 7th at 7am, followed by the south side of Queen Street East on February 8th at 7pm, for our prep vehicles arriving on February 9th at 7am. We will reserve the north side of Queen Street East with cones on February 9th at 9am. The remaining area will be coned on February 10th at 9am ahead of our tech unit arrival later that evening. All wrap out will be completed by 7pm on Saturday, February 14th.

**Pursuant to the City of Toronto's Filming Guidelines, we are requesting your approval on the exemption of by-law:
#5. Restrictions & Limitations: Filming between 11PM-7AM (crew precalls/vehicle movement)**

Displaced permit parkers affected by our filming activities are kindly asked to park in their driveways (if applicable), surrounding streets or nearby pay lots. On our filming day, please contact Cody Nelson from the Locations Department at (416) 938-6925. We will direct you to available parking and/or reimburse your parking receipt.

All of our filming & related activities are undertaken under the authority & approval of the City of Toronto Film, Television and Digital Media Office. ANY INTERMITTENT TRAFFIC STOPPAGES/CONTROL will be conducted under the safe supervision of the Toronto Police Service.
